MILCOR STANDARD PRODUCT WARRANTY

Subject to the terms, conditions, and limitations stated below, Milcor warrants that the Access Doors ("Product") are free from manufacturing defects at the time of sale. Milcor further warrants the Product will not prematurely deteriorate because of weathering for a period of one (1) year from date of sale. This Product Warranty applies only to the Product and does not apply to labor, materials or construction details. If upon inspection by Milcor the Product is found to be defective, Milcor may provide a replacement Product or a substitute at its' sole discretion.

TERMS, CONDITIONS, LIMITATIONS

- 1. Ow ner shall provide Milcor with written notice within thirty (30) days of the discovery of any alleged defects in the Product. Ow ner should contact a Milcor Representative at 800-624-8642.
- 2. If upon Milcor inspection, Milcor determines that the defect in the Product is caused by material deficiencies, except as provided in Paragraphs No. 3 and No. 4, Ow ner's remedies and Milcor liability shall be limited to Milcor's replacement of the Product or its' equal, at Milcor's sole discretion.
- 3. This Warranty shall not be applicable if, upon Milcor's inspection, Milcor determines that any of the following has occurred:
 - (a) The Product is damaged by natural disasters, including, but not limited to, lightning, fire, hail, earthquake, tornado, hurricanes, and gales; or
 - (b) The Product is damaged by any acts of negligence, accidents or misuse, including, but not limited to, vandalism, civil disobedience, or acts of w ar; or
 - (c) Product not furnished by Milcor is used and fails or causes defects in Milcor Product; or
 - (d) Deterioration or failure of building components, including, but not limited to, walls, mortar, machinery, HVAC units, etc., occurs and causes damage; or
 - (e) Deterioration or failure of the Product caused by, including, but not limited to, harmful gases in insulations, defects or harmful substances in insulations or other underlying materials; or
 - (f) Usage or spillage of material or substance not compatible with the Product, including, but not limited to, petroleum based products, oils, acids, animal fats, harmful chemicals, and the like, which come in contact with the Product and causes deterioration.
- 4. Milcor shall have no obligation under this Warranty unless all the bills for the Product have been paid in full.
- 5. Milcor's failure at any time to enforce any of the terms or conditions stated herein shall not be construed to be a waiver of such terms or conditions.
- 6. This Warranty supersedes and is in lieu of any and all other expressed warranties that are in conflict with the terms and conditions stated herein.
- 7. No representative of Milcor has authority to make any representations or promises except as stated herein.
